

OUR MISSION

To promote the dignity and independence of seniors who are in need of nutritious meals, companionship, and Alzheimer's care.

OUR SERVICES



Meal On Wheels prepares and delivers fresh, hot and nutritious meals each weekday to homebound seniors throughout Bexar County. For many recipients, our meals are the only source of nutrition received each day. Our meal deliveries provide personal contact, combat loneliness and provide critical intervention in life threatening situations.



Grace Place is San Antonio's only licensed non-profit adult day activity center exclusively for seniors suffering from Alzheimer's. Grace Place Each center provides a secure and nurturing environment where our clients engage in activities that focus on their abilities rather than disabilities. We now have three locations serving Northwest, Northeast, and Central San Antonio.

Services

Companionship Senior Companion Program is a peer-to-peer program where caring senior volunteers befriend homebound seniors in their community. The program is designed to foster independence among seniors by engaging them in community service, providing them companionship opportunities, and offering respite to both professional and family caregivers. Those that are 21 and over may volunteer through the Elder Friends program.

42% of Meals On Wheels recipients live alone; 55.4% live below poverty level.

43% of Companion Services clients are over 80 years old.

81% of Grace Place participants (Alzheimer's sufferers) engaged in center activities that helped to stabilize their daily routine and encourage night time sleeping.

WHAT WE ACCOMPLISHED

DURING 12 MONTHS ENDING JUNE 30, 2014

MEALS ON WHEELS

924,146 meals were delivered to 5,395 seniors in Bexar County.

96% of MOW recipients feel less isolated than before meal deliveries began.

GRACE PLACE

We provided 22,776 days of care for 268 Alzheimer's patients.

96% of Caregivers reported they were able to get needed rest, continue or return to work, and/or found useful resources and information about Alzheimer's.

COMPANIONSHIP SERVICES

117 Companions provided 76,881 hours of companionship and minor personal assistance to 200 homebound and isolated adults.

97% of Seniors no longer active in the workplace found value in helping others.


