Two years ago, Roy and Joyce started receiving Meals on Wheels and Roy recalls being pleasantly surprised by the food. Joyce's mother had received meals many years before; "I saw some of her meals, so I wasn't expecting much," he chuckles. Roy Brewer is 93 years old. He is blind and navigates his home by touch. Now, after the recent death of Joyce, his wife of 74 years, he lives alone.

His neighbor, Mr. Appleton, has stepped in to help him with his affairs,

assisting with automatic bill payments and checking in daily, but he doesn't cook. After receiving meals for a little over a year, Joyce passed away; leaving Roy alone in the home they shared for five decades. "I've studied long and strong about giving up the house and going into assisted living. But this has been home for 55 years—I like it, I know it, and I can get around even though I'm blind."

Roy is lucky. He has a support structure enabling him to remain in his home.


Roy has us programed into his phone!
